Reform of the Indian Arbitration Law

The Arbitration and Conciliation Ordinance 2015, amending the 1996 Arbitration and Conciliation Act, entered into force on 31 December 2015, with the aim to make Indian law more arbitration friendly and to attract foreign investment. Several changes are brought with this amendment: Fast track procedure: The Ordinance expressly instates a new procedure: parties may now [...]

Closing cocktail of the first promotion of the University Diploma "MOOC in Arbitration Law"




